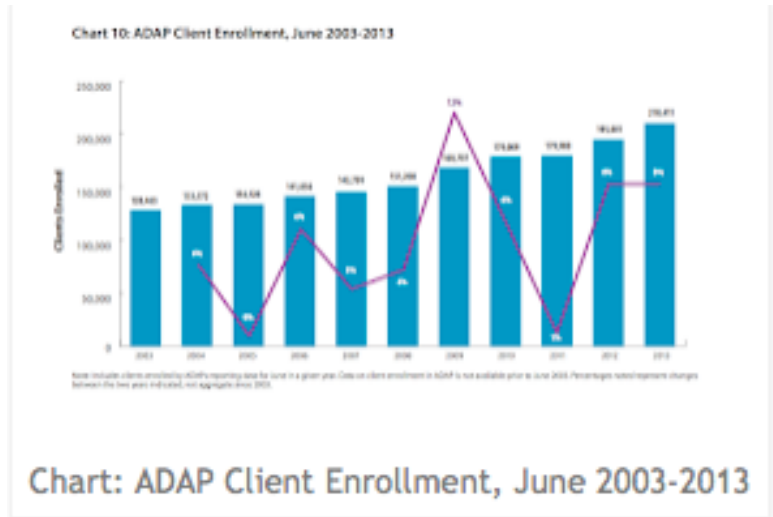


SUMMARY:

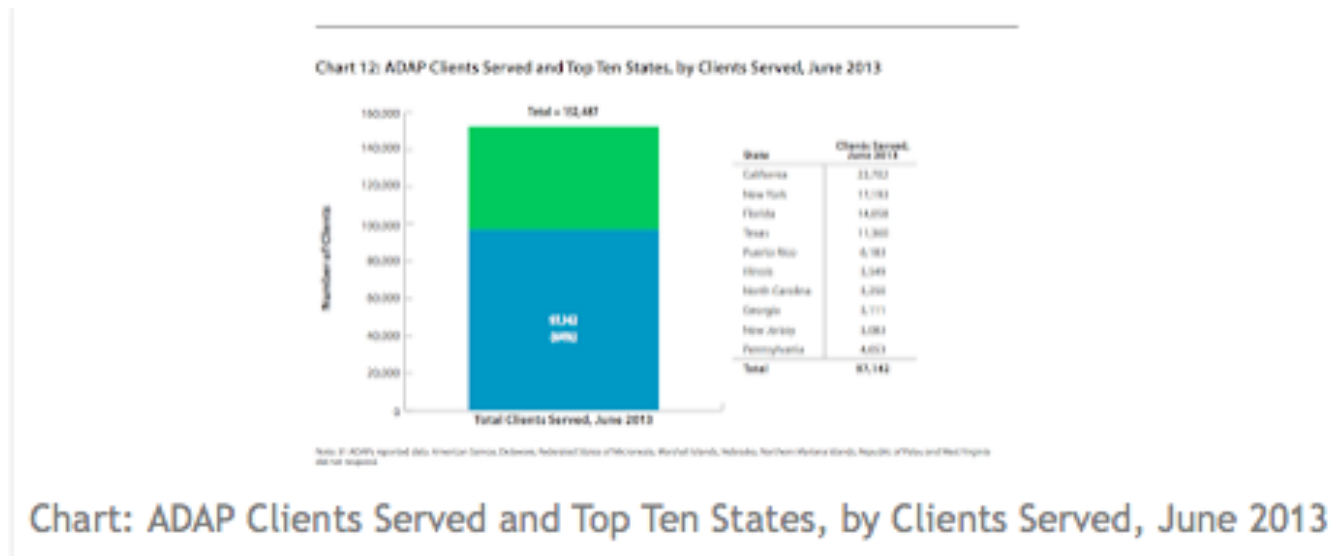
Over the last year, one of the most frequently asked questions by people living with HIV/AIDS, public policy advocates, representatives from the health care and pharmaceutical industries and others, "What is the future of the AIDS Drug Assistance Program now that the Affordable Care Act is law?"

The answer is simple: It is too early to know for certain!

At first glance, data trends suggest that the passage of the ACA and its subsequent implementation has not slowed down client enrollment in ADAPs nationwide. According to the "**National ADAP Monitoring Project - Annual Report**," published by the National Alliance of State & Territorial AIDS Directors (NASTAD), client enrollment increased by over 15,000 between 2012 and 2013, or about an 8% increase. Last year, over 210,000 people living with HIV/AIDS were enrolled in ADAP.¹



Not surprisingly, California has the largest statewide enrollment, with 22,702 clients, followed by New York with 17,193 clients, and Florida with 14,058 clients. Over sixty percent (97,142 clients) of the total clients served by ADAP were served by the top ten states -- including Texas, Puerto Rico, Illinois, North Carolina, Georgia, New Jersey and Pennsylvania).²

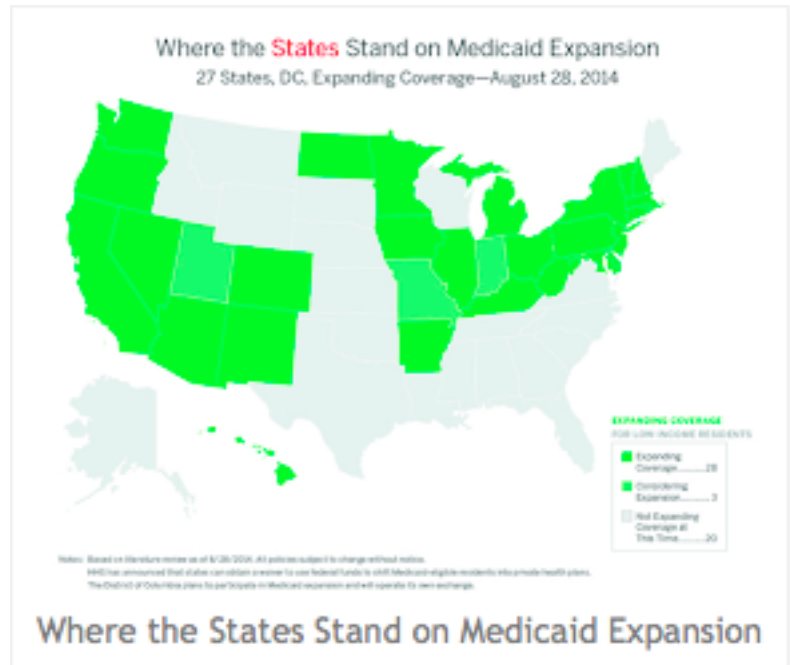
One of the consistent themes heard at our 2014 Summit ("Intersection between ACA & ADAP") and 2014 Annual Conference ("Future of the AIDS Drug Assistance Program") was without concrete data, it is premature to make any assumptions about the Ryan White CARE Act, in general, and the AIDS Drug Assistance Programs, specifically. Another message that was fairly consistent, there is a significant disconnect between the advocacy work being done on Capitol Hill and the boots on the ground in local communities. It is also ill advised to open-up the Ryan White law until we can better evaluate the intersection with the ACA, as well as the future of ADAP!

Clearly, ADAPs will remain a vital safety net for thousands of people living with HIV/AIDS next year and into the foreseeable future.

Probably one of the biggest unknown variables is the ongoing Medicaid expansion. "Spotty" is probably the best word to describe whether states are exercising the option to expand their Medicaid programs. Not surprisingly, some of the most resistance has come from southern states controlled by Republican Governors, or Republican State Legislatures.

Another added variable is the Republican electoral wave during the 2014 midterm election. Whereas some pragmatic Republican legislators have moved beyond the "Repeal & Replace" chatter about Obamacare, there remain plenty of hard-liners who wish to do away with the law, or at least strip it of some major provisions. It is clearly too early to tell, but President Obama's veto pen is probably the law's best defense.

The ACA is also fueling new challenges for people living with HIV/AIDS; among them, emerging discriminatory practices. Monitoring these trends is an essential responsibility for all ADAP stakeholders. These facts were illuminated during our free webinar, "Update on ACA Discriminatory Marketplace Exchange Practices," which was presented in collaboration with Lambda Legal. TIMELINE OF EVENTS:

January 23, 2014 – The ADAP Advocacy Association, together with the Community Access National Network (CANN) "Hepatitis: Education, Advocacy & Leadership" (HEAL) coalition, announced that it would host its annual summit on Sunday, April 13th – Tuesday, April 15th, 2014. The summit was themed "The Intersection Between ACA & ADAP Summit."

February 19, 2014 – The ADAP Advocacy Association urged the Centers for Medicare and Medicaid Services (CMS) to issue a mandate to insurance companies dictating that they accept third party payments from Ryan White CARE Act grantees for Marketplace Exchange insurance plans.

February 27, 2014 – The ADAP Advocacy Association expressed concern over the news that waiting lists were once again being reported under the AIDS Drug Assistance Programs (ADAPs). According to the National Alliance of State & Territorial AIDS Directors, Utah had placed three people living with HIV/AIDS on its ADAP waiting list.



March 25, 2014 – The ADAP Advocacy Association applauded the Centers for Medicare and Medicaid Services (CMS) for their interim final rule requiring health insurance companies participating in the Marketplace Exchange under the Affordable Care Act (ACA) to accept third-party payments from Ryan White CARE Act funds for cost sharing and premiums. The mandate alleviated one of the unintended barriers that could have prevented access to care for patients living with HIV/AIDS.

April 2, 2014 – The ADAP Advocacy Association announced the appointment of two new members to its Board of Directors. Aaron Baldwin of San Francisco, who works as an agent with New York Life Insurance and designed the first of its kind Positive Planning annuity for the HIV-positive community, and Chrys Thorsen of Los Angeles, who is a leading technology consultant and former IT project lead on a PEPFAR-funded electronic health record program.

April 8, 2014 – The ADAP Advocacy Association released its 2013 Annual Report. Whereas the AIDS Drug Assistance Program waiting lists were finally eliminated last year, significant fiscal pressures continued to restrict access to appropriate, timely care and treatment in many states. The implementation of the Affordable Care Act was expected to provide some relief, but uncertainty also remained over the possible unintended consequences of the law.

May 16, 2014 – The ADAP Advocacy Association released an important White Paper on the impact of HIV/AIDS in the South, entitled "**THE SOUTHERN EPIDEMIC: Are the South's cultural, political and societal barriers making it difficult for public health programs, such as the AIDS Drug Assistance Programs, to function effectively in this region?**" The White Paper examined the numerous factors contributing to people living with HIV/AIDS in this region of the country experiencing more barriers to access healthcare. It also addressed the disproportionate impact of waiting lists under ADAPs that have historically plagued the South.

May 27, 2014 – The ADAP Advocacy Association opened nominations for its 2014 Annual ADAP Leadership Awards. The awards would recognize individual, community, government and corporate leaders who are working to improve access to care and treatment under the AIDS Drug Assistance Programs.

June 10, 2014 – The ADAP Advocacy Association released the Final Report from “The Intersection Between ACA & ADAP Summit” – which was held in partnership with the Community Access National Network (CANN) in Washington, DC earlier in the year. The purpose of the Final Report was to convey some of the programmatic changes, improvements and reforms that could be leveraged under the ACA to better serve people living with HIV-infection and/or Viral Hepatitis.

The following chart demonstrates the diversity of the organization’s funding in 2014:

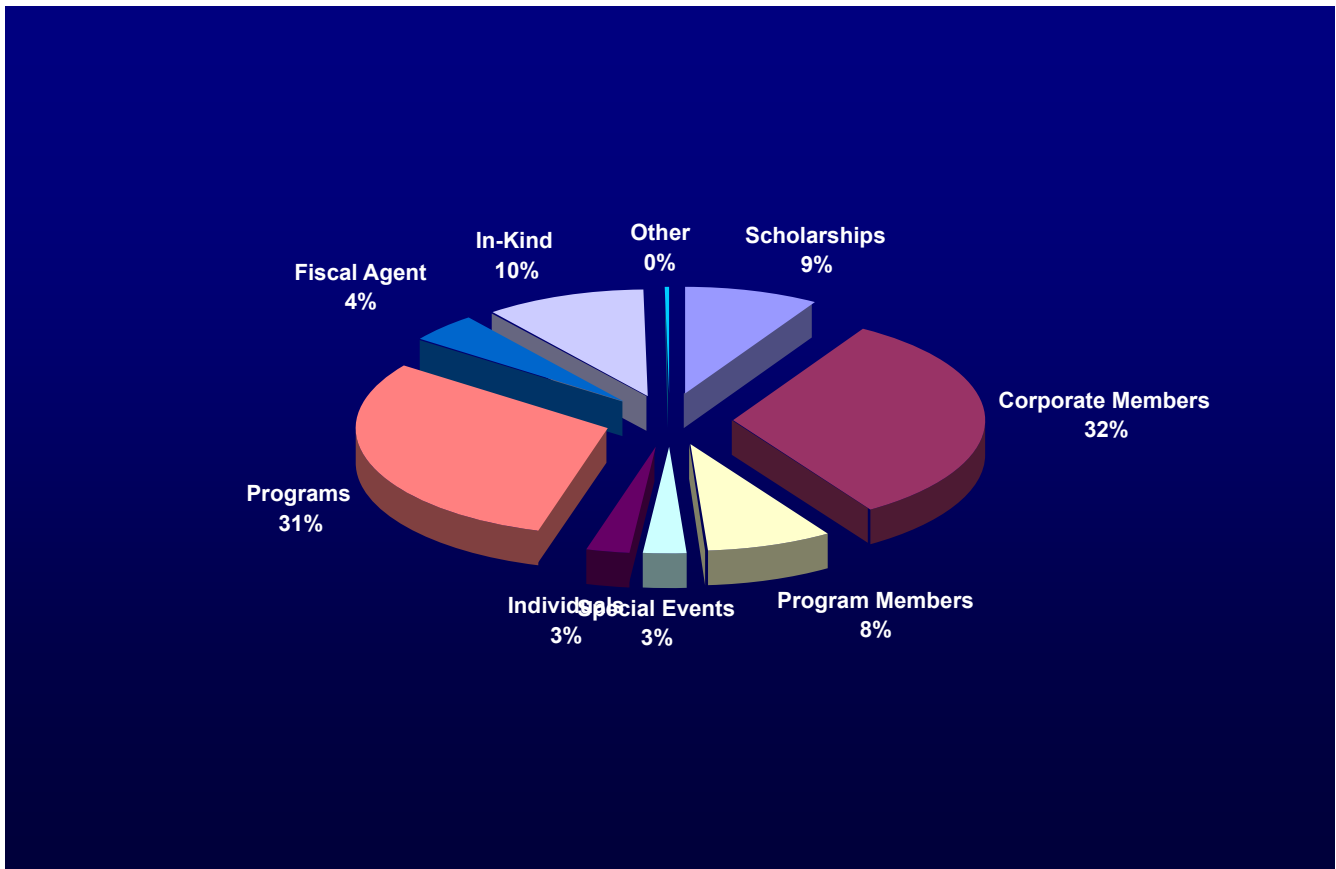


Figure 1 - 2014 Revenue by Source
