WASHINGTON, D.C. – The ADAP Advocacy Association today shared its new comprehensive patient advocacy report, HIV LONG-ACTING AGENTS: Policy Considerations for Injectable Therapies under the Ryan White HIV/AIDS Program & State AIDS Drug Assistance Programs. This document provides a checklist of the main concepts requiring robust policy and programmatic conversations with people living with HIV/AIDS, as well as all the other local stakeholders within the local service delivery system regarding injectables.
