[Florida Legislature approves bill restoring funds to AIDS drug assistance program](#)

The ADAP legislation described in the article above begins on page 5 of [the bill](#). As reported, the governor is expected to sign the bill, a stopgap measure to allow advocacy for a longer-term solution. In summary, the bill includes \$31 million to continue ADAP eligibility for people at up to 400% of FPL through June 30, 2026, in addition to cost-sharing assistance for people with Medicare or private insurance coverage. The coverage is limited to direct dispensing of medications for the formulary in effect on March 1, 2026, which excludes Biktarvy and restricts access to Descovy.
